Overload Teaching by Professional and Executive Staff

- 1. The meeting convened at 8:00 a.m.
- 2. VP Vaughan distributed information to the Vice Presidents regarding the amount of overload teaching done by the classified, professional, and executive staffs in their areas. Several staff members have raised concerns regarding compensation for work done during normal work hours. A related concern is different compensation for staff doing equivalent work. At the same time, several programs are heavily dependent upon the use of WSU staff as adjunct faculty. This topic will be further discussed at a subsequent meeting.

The following language from PPM 3-48, Extra Compensation (Salaried Non-Faculty) is relevant. "Total extra compensation in any fiscal year may not exceed the following limits:

- a. The supervising dean-level administrator may approve up to 15% of base salary.
- b. The supervising vice president may approve up to one-third (33 1/3 percent) of base salary."

3. VP Vaughan and VP Tarbox reviewed the remodeling of the Stewart Library. In addition to the construction of the new entrance, Special Collections is currently being remodeled. It is anticipated that the major portion of the remodeling will be completed by the start of the fall term. However, some work will continue after the term has started.
