Customer Service Week and Customer Service Updates

9. Sarah Rivkind, from the Office of Workplace Learning, reported on current customer service projects. She provided a proposed budget for activities during Customer Service week during the first week of October. One proposed activity would be mystery calls made by an independent company. Those calls could be recorded for the purpose of training examples. President's Council requested that the Office of Workplace Learning work with the division vice presidents to determine if there are areas they would like to receive the customer service calls and whether they could be recorded.
